SUBJECT: Grant Proposal to Increase the Appropriation for Latchkey Childcare Funding

SUMMARY

This report requests that the City Council authorize the City Manager to submit a grant proposal to the California State Department of Education, Child Development Division, to increase the current grant funding for the Recreation Division's Latchkey Program from \$131,298 to a maximum of \$218,474.

BUDGET AND FINANCE COMMITTEE ACTION

The attached report will be reviewed by the Budget and Finance Committee at their meeting of September 23, 1987. Results of that meeting will be presented orally to the City Council.

RECOMMENDATION

SUBJECT: Grant Proposal to Increase the Appropriation for
Latchkey Childcare Funding

SUMMARY

This report requests that the City Council authorize the City Manager to submit a grant proposal to the California State Department of Education - Child Development Division to increase the current grant funding for the Recreation Division's Latchkey Program from \$131,298 to a maximum of \$218,474.

BACKGROUND INFORMATION

On June 16, 1987 the City Council authorized, by resolution, the City Manager to submit Local Agreement No. CD-1303 to the California State Department of Education - Child Development Division on behalf of the Recreation Division of the Department of Parks and Community Services. The agreement is for continued funding to provide a "Latchkey" program (4th "R") for children in the amount of \$131,298 for the 1987-88 fiscal year. Previous Latchkey grants were awarded for \$36,911 for 1985-86 fiscal year and \$130,000 for the 1986-87 fiscal year. During fiscal year 1986-87 the Department operated twelve 4th "R" sites, provided childcare for over 500 children, and subsidized 87 participants.

This report requests authorization to apply to the State of California for additional funding currently available for use in fiscal year 1987-88 in Sacramento County. These additional funds became available due to some counties not receiving their total funding request in fiscal year 1986-87, therefore, the remaining funds are being offered again to interested applicants. The City may receive a portion of the additional funding of \$87,176, or the entire amount. The additional funding would expand the current 4th "R" program to approximately thirty-four additional children and further subsidize the cost of the program for low income participants.

FINANCIAL DATA

The FY 1987-88 City budget includes \$131,298 for the 4th "R" program to be funded by the State of California, Department of Education grant. Up to \$87,176 in additional grant funds may be awarded to the City, thus expanding the 4th "R" program.

No additional City funds are required.

RECOMMENDATION


