SUBJECT: Approval of Reimbursement Agreement for Country
Scene Unit No. 2, Improvement Proceeding No. 4961

BACKGROUND INFORMATION

As a consideration of the approval of the tentative subdivision map for Country Scene Unit No. 2, a private contract was required for the construction of the subdivision improvements. The owners of the property, Underwood-Wiese Co., have executed a contract with Granite Construction Company for said improvements.

The construction of Franklin Boulevard is a major arterial and calls for City participation in it's construction. The City's share for constructing Franklin Boulevard, based on the bid prices, is \$9,728.14.

FINANCIAL DATA

Funds for the City's portion (\$9,728.14) will be paid out of the City Engineers Budget No. 2-09-2600-2402-4820 when the funds become available and according to where this particular project appears on the priority list established by the City Engineer.

RECOMMENDATION

It is recommended that the attached Resolution be adopted which authorizes and directs the City Manager and City Clerk to execute an Agreement For Reimbursement.
