SUBJECT: Resolution Authorizing Execution of Agreement Between M & M Consultants and the City of Sacramento for the Preparation of Improvement Plans for East Del Paso Heights Street Assessment District No. 1

SUMMARY:

Presented herewith for approval is a consultant services agreement for an amount not to exceed \$30,200 between M & M Consultants and the City of Sacramento for the preparation of engineering plans for the East Del Paso Heights Street Assessment District No. 1.

BACKGROUND:

This agreement is presented to conform to the guidelines of the policy for Retention of Professional Consultants for City Projects adopted May 10, 1977. The charges shall represent hourly charges for personnel involved in the work, materials, supplies, stakes, mileage and prints needed in the work process, with the total fee not to exceed \$30,200 plus \$80.00 per right-of-way plat and legal description.


FINANCIAL:


RECOMMENDATION:
