

## RESOLUTION NO. 2006-435

Adopted by the Sacramento City Council

June 13, 2006

### DECLARING THE RESERVE FUNDS, REDEMPTION FUNDS, AND CONSTRUCTION FUNDS AS SURPLUS, ORDERING THE DISPOSITION OF SURPLUS AMOUNTS FOR THE BELOW LISTED ASSESSMENT DISTRICTS, AND APPROVING THE ASSESSMENT DISTRICT CLOSEOUT AND FINDINGS REPORT

#### BACKGROUND

- A. The City Council has previously adopted Resolutions of Intention to order the construction of improvements in the following Assessment Districts (the "Districts") under the provisions of the Municipal Improvement Act of 1913 of the California Streets and Highways Code:


