RESOLUTION NO. 3526 DIRECTING THE SUPERINTENDENT OF STREETS TO NOTIFY PROPERTY OWNERS TO CONSTRUCT SIDEWALKS ON PORTIONS OF PERKINS WAY, BETWEEN FREEPORT BOULEVARD AND THE WESTERN PACIFIC RAILROAD COMPANY RIGHT OF WAY, AND FIXING THE DAY, HOUR AND PLACE OF HEARING OBJECTIONS THERETO.

RESOLVED, that pursuant to Division 7, Part 3, Chapter 27 of the Streets and Highways Code of the State of California, the Superintendent of Streets is hereby directed to notify the property owners to construct cement concrete sidewalks as required by the City of Sacramento Standard Specifications on the frontage of property located in Hillcrest Park or H. J. Goethe Company's Subdivision No. 68 (as the same is recorded in the office of the Sacramento County Recorder) described as follows:

- (1) East 67 feet of Lot 6803 and Lot 6804, Except the East 41.25 feet of the south 99.5 feet.
- (2) East 41.25 feet of the South 99.5 feet of Lot 6804.
- (3) Lot 6809
- (4) Lot 6810
- (5) Lot 6818
- (6) East 48.01 feet of the North 95 feet of Lot 6819.

BE IT FURTHER RESOLVED that the hour of 7:45 o'clock p. m. on the 15th day of June, 1961, in the Council Chamber of the City Council of the City of Sacramento in the City Hall on "I" Street between 9th and 10th Streets, in said City, is hereby affixed as the day, place and time for hearing of objections or protests, if any, and show cause why the proposed work and improvement shall not be carried out in accordance with this Resolution.
