SUBJECT: REVISED CLASSIFICATION TITLES-SANITARY CHEMIST SERIES

SUMMARY

On December 16, 1980 the Civil Service Board approved revisions to the Sanitary Chemist I and Sanitary Chemist II class specifications. As a part of those approved revisions the classification titles were retitled to Sanitary Chemist and Senior Sanitary Chemist. A resolution revising the classification titles in the salary resolution is attached for adoption by the City Council.

BACKGROUND INFORMATION

Because of an anticipated vacancy in the Sanitary Chemist I classification, the class specifications for both Sanitary Chemist I and II were reviewed by the Personnel and Engineering Departments. It was determined that some housekeeping revisions had to be made due to changes in the duties and responsibilities of the classes since the last revisions in 1972. As a part of the general revisions the titles were revised in order to conform with standardized class specification terminology.

FINANCIAL DATA

There will be no financial impact as a result of the revised classification titles.

RECOMMENDATION

It is recommended that the City Council approve the attached resolution providing for the change of titles in the Salary Resolution #80-145.
