OWNER - BUILDER DECLARATION

I affirm under penalty of perjury that I am exempt from the Contractors License Law (Chapter 9 (commencing with Section 7000) of Division 8 of the Business and Professions Code) or that he or she is exempt therefrom and the basis for the exemption. Any violation of Section 7031.5 by any applicant for a permit shall be a civil penalty of not more than five hundred dollars.
