

RESOLUTION No. 520

Adopted by The Sacramento City Council on date of

JANUARY 16, 1948.

WHEREAS, under and by virtue of Section 32 of Ordinance No. 304, Fourth Series, passed November 12, 1926, as amended by Ordinance No. 775, Fourth Series, passed March 11, 1938, the City Manager has found that it is necessary for the convenience of the public to designate time limit requirements for the parking of vehicles,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That vehicles of all kinds parking in the metered area will be restricted as follows:

TWO HOUR PARKING AREA EXCEPT THOSE PORTIONS DESCRIBED AS 24 MINUTE PARKING AREA:

3rd Street from "I" Street to "L" Street;
 4th Street from "I" Street to "L" Street;
 5th Street from "I" Street to "L" Street;
 6th Street from "H" Street to "I" Street;
 7th Street from "H" Street to "I" Street;
 7th Street from "L" Street to Capitol Ave.;
 8th Street from "H" Street to "I" Street;
 8th Street from "L" Street to Capitol Ave.;
 9th Street from "H" Street to "I" Street;
 9th Street from "L" Street to "N" Street;
 10th Street from "H" Street to "I" Street;
 10th Street from "L" Street to "N" Street;
 11th Street from "H" Street to "I" Street;
 12th Street from "H" Street to "I" Street;
 14th Street from "I" Street to "L" Street;
 15th Street from "J" Street to "L" Street
 "I" Street from 3rd Street to 6th Street;
 "I" Street from 11th Street to 14th Street;
 "J" Street from 3rd Street to 5th Street;
 "J" Street from 13th Street to 15th Street;
 "K" Street from 3rd Street to 5th Street;
 "K" Street from 13th Street to 15th Street;
 "L" Street from 3rd Street to 15th Street;
 Capitol Avenue from 8th Street to 9th Street;
 "N" Street from 9th Street to 12th Street;
 "N" Street south side from 12th Street east 230 feet;
 Terminal Way from 11th Street to 12th Street.

24 MINUTE PARKING AREA.

- 4TH STREET - west side of 4th Street, from a point 98 feet south of the south line of "J" Street, south to the J-K Alley.
- 6TH STREET - west side of 6th Street, from a point 17 feet south of the south line of "K" Street, south 80 feet.
- 7TH STREET - east side of 7th Street, from the south line of "J" Street, south to the J-K Alley.
- 8TH STREET - west side of 8th Street, from the south line of "J" Street south to the J-K Alley.
- 10TH STREET - west side of 10th Street, from a point 15 feet south of the south line of "J" Street, south 40 feet.
- 10TH STREET - west side of 10th Street, from a point 15 feet south of the south line of the K-L Alley, south 57 feet.
- 10TH STREET - east side of 10th Street from a point 75 feet south of the south line of "J" Street, south to the J-K Alley.
- "I" STREET - north side of "I" Street from a point 50 feet west of the west line of 9th Street, west to 8th Street.
- "J" STREET - south side of "J" Street from a point 105 feet east of the east line of 7th Street, east to 8th Street.
- "K" STREET - north side of "K" Street from a point 105 feet west of the west line of 14th Street, west 42 feet.
- CALIFORNIA STREET - north side of California Street, from the east line of 7th Street, east 20 feet.
