SUBJECT: Extending Time on Contract for Granger's Dairy
Unit No. 2 Assessment District, Improvement
Proceeding No. 4784

BACKGROUND INFORMATION

The Council awarded a contract to Teichert Construction on June 27th, 1978 for constructing concrete curbs, gutters and sidewalks, sanitary and storm sewers, sewer services, drainage facilities, street name signs, asphaltic concrete pavement, water distribution system complete and street lighting system complete in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for January 6th, 1979. Since that time, three extensions of time have been granted, making the current completion date February 29th, 1980. The work has been completed, but quantities must be finalized and the assessment spread.

RECOMMENDATION

It is recommended therefore, that the Council grant an extension of sixty days to Teichert Construction by adoption of the attached Resolution Extending Time On Contract.
