## AUTHORIZATION TO APPROPRIATE AGENCY FUNDS FOR HOMELESS PROGRAM ACTIVITIES

NOW, THEREFORE BE IT RESOLVED BY THE REDEVELOPMENT AGENCY OF THE CITY OF SACRAMENTO:

Section 1: The Executive Director is authorized to allocate \$76,000 in Agency funds to resume the services of the Shared Housing and Resource Empowerment (SHARE) Program for the balance of 1990.

Section 2: The Executive Director is authorized to allocate \$11,000 in Agency funds to the Transitional Living and Community Support (TLCS) Agency to expand the office space for the Housing and Empowerment Program for the homeless mentally ill.

Section 3: The Executive Director is authorized to allocate \$25,185 in Agency funds to St. John's Shelter to expand support services to homeless women and children.

Section 4: The Executive Director is authorized to amend the Agency budget accordingly.
