SUBJECT: Adoption of a Special Street Section for a Portion of Pocket
Road

SUMMARY

This report recommends the adoption of a special 110 foot right-of-way street section, elimination of on-street parking, and adoption of an off-street bicycle trail for a portion of Pocket Road between Greenhaven Drive and point southeast of Blackwater Way. This item was heard before the Transportation and Community Development Committee on March 17, 1987.

BACKGROUND

The March 17, 1987 Transportation and Community Development Committee staff report is attached for your information.

None applicable. The portion of Pocket Road the City may reimburse developers for overwidth pavement construction remains the same with this alternative.

SUBJECT: Adoption of a Special Street Section - A Portion of Pocket Road

SUMMARY

This report recommends the adoption of a special 110 foot right-of-way street section for a portion of Pocket Road between Greenhaven Drive and a point southeast of Blackwater Way.

BACKGROUND

In May of 1986, development of the South Pocket area began with the construction of Dutra Ranch and the L.P.P.T. properties. As part of these subdivisions an alternative 110 foot right-of-way cross section for Pocket Road was proposed and constructed. It was anticipated that those portions of Pocket Road not part of the subdivisions would be constructed at the same time through assessment district proceedings. The negotiations to form an assessment district, however, were unsuccessful. This leaves portions of Pocket Road to be improved by future development. Staff recommends action be taken to assure the street cross section used in the future is consistent with the alternative street section approved by Public works and constructed this past summer by L.P.P.T.

Staff recommends the City Council formally adopt the modified section for the affected portions of Pocket Road. The limits of the affected portion is that section of Pocket Road between Greenhaven Drive and a point approximately 417 feet southeast of Blackwater Way (see Exhibit "A").

Exhibit "B" depicts the City standard 110 foot right-of-way cross section and the alternative cross section constructed last year. The alternative section differs from the City standard by the following:

- 1) Increases the landscaped area behind the curb by the 7 feet on the river side of Pocket Road (south and west sides).

- 2) Increases the landscaped area behind the curb by 5 feet on the land side of Pocket Road (north and east sides).
- 3) Provides off-street bicycle facilities on the land side of Pocket Road.
- 4) Provides on-street bicycle lanes on both sides of Pocket Road.
- 5) Eliminates on-street parking on both sides of Pocket Road.
- 6) Reduces the pavement area from 35 feet to 30 feet on each side of the center median.
- 7) Reduces the center median from 14 feet to 10 feet.


FINANCIAL DATA

None applicable. The portion of Pocket Road the City may reimburse developers for overwidth pavement construction remains the same under both alternatives.


RECOMMENDATION

**ADOPTING A SPECIAL 110 FOOT
RIGHT OF WAY CROSS SECTION FOR A PORTION OF
POCKET ROAD, ELIMINATING ON-STREET PARKING AND
MODIFYING BICYCLE MASTER PLAN**

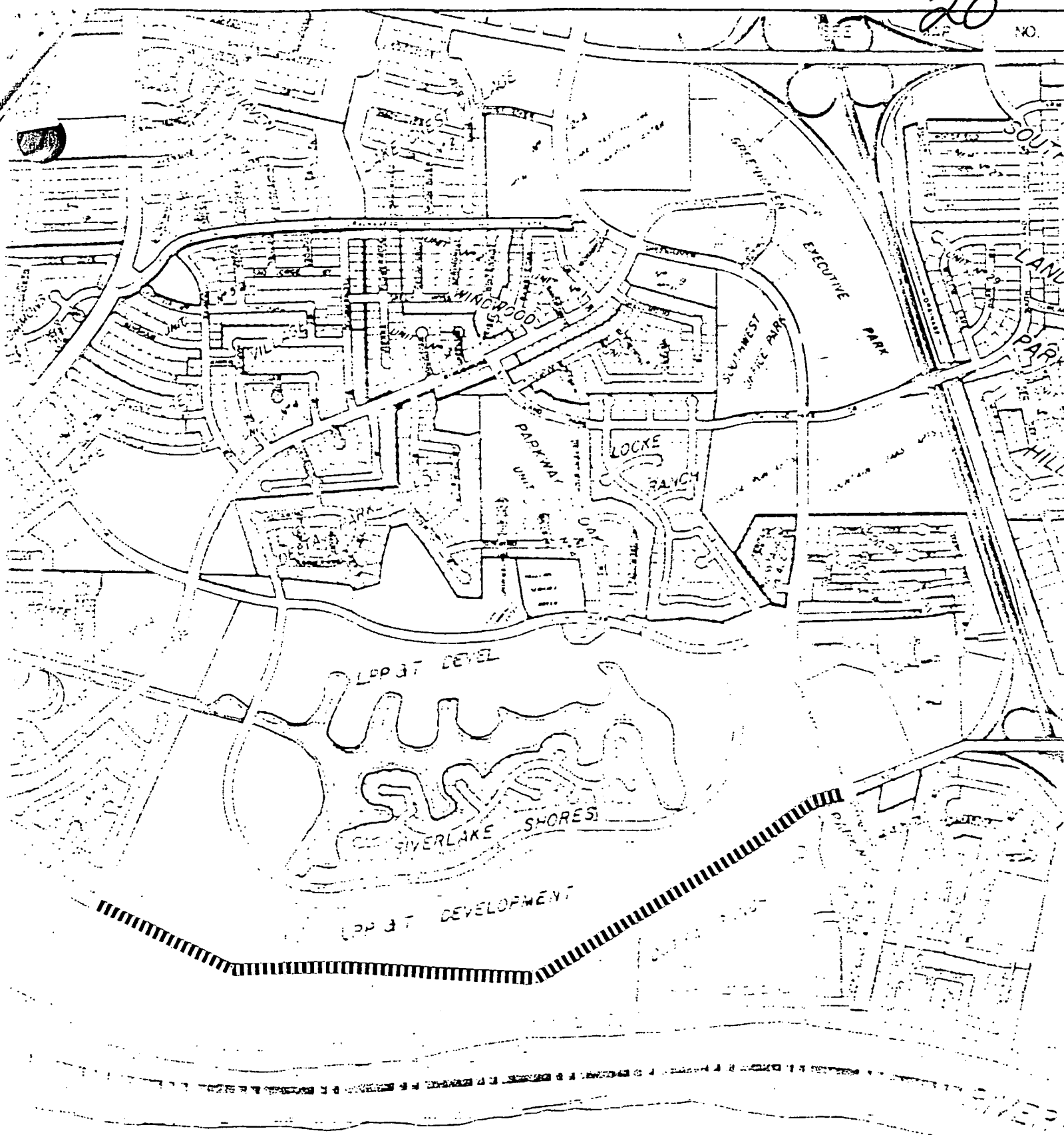
BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO THAT;


- 1. As authorized in Section 40.309 of the City Code, a special section for Pocket Road between Greenhaven Drive and a point approximately 417 feet southeast of the intersection of Blackwater Way and Pocket Road as shown on the attached Exhibit is hereby approved.
- 2. As authorized in Section 25.103 of the City Code, when signs are posted giving notice thereof, parking shall be prohibited on Pocket Road between Interstate 5 and a point approximately 417 feet southeast of the intersection of Blackwater Way and Pocket Road.
- 3. Resolution 78-396 is hereby modified to include a class 3 bicycle trail on the north and east sides of Pocket Road between Greenhaven Drive and a point approximately 417 feet southeast of the intersection of Blackwater Way and Pocket Road.
