SUBJECT: Engineering Services for Chemical Control System
Modifications at Sacramento River Water Treatment
Plant

SUMMARY

The Division of Water & Sewers solicited proposals from engineering firms for the subject project. The proposals were evaluated and the firms interviewed by the Consultant Selection Committee. It is recommended that the Council approve the selection of James M. Montgomery, Consulting Engineers, Inc., for the project and authorize negotiation of fees to proceed.

BACKGROUND INFORMATION

Over the past few years the City has been upgrading and making modifications to the Sacramento River Water Treatment Plant. This was necessary so the City could demonstrate to the State during its water rights renewal process that the City had the ability and need to use all their existing water rights. In addition, the modifications provide the additional capacity to furnish surface water to North Sacramento and the Natomas area.

As part of this upgrading of the Plant, the City had a study completed analyzing the existing disinfection facilities and reviewing disinfection alternatives. The study concluded that chlorination was the preferred alternative based on cost, safety and ease of operation and maintenance. Part of this project will be the design of the chlorination facilities recommended in that study.

The alum feed system for the Plant does not have the needed capacity for the new anticipated flows. Also, the system is old and has become a maintenance problem. This project will analyze the alum system and design a new facility.

The various control functions for the Plant are located throughout the Plant site. They are very outdated, making it difficult to obtain repair parts. The project will design the consolidation of the various controls into a central control room and provide new state of the art controls for improved

reliability and operator efficiency. This consolidation of controls is consistent with our ultimate goal of reducing operator requirements.

FINANCIAL DATA

The project is part of the original Sacramento River Water Treatment expansion project budgeted in 1973-74 and 1974-75 (4-13-3020-1501-4820). Adequate funds are available to cover the anticipated costs of this project.

RECOMMENDATION

It is recommended the Council approve the selection of James M. Montgomery, Consulting Engineers, Inc., and authorize the negotiations to determine fee for this work to proceed.
