Summary:

Section 2.90.080 of Title 2 of the Sacramento City Council states that this chapter shall expire on December 31, 2005, and the Development Oversight Commission shall cease to operate after that date.

Committee/Commission Action:

On April 26, 2005, the Sacramento City Council adopted Resolution 2005-283 approving the Year 2004-2005 Annual Report of the Development Oversight Commission and directing the Office of the City Attorney to prepare an ordinance to amend Chapter 2.90 of the Sacramento City Code to extend the life of the Chapter and services of the Commission to December 31, 2010.

Background Information:

The City of Sacramento Development Oversight Commission (DOC) is comprised of building industry representatives and members of the public appointed by the Mayor and approved by City Council to assure follow through of recommendations from Mayor's Commission on Development that were approved by the City Council on July 20, 1999. In addition, the DOC provides a forum that enables the public and city staff to introduce and to discuss suggestions, comments, and concerns regarding the procedures and processes of the city's development services function.



BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1
