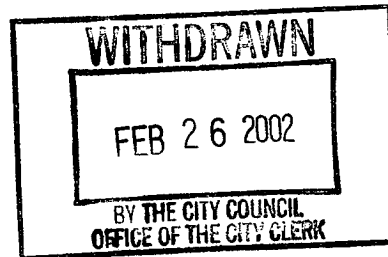

**RECOMMENDATION:** It is recommended that the item be passed for publication of title and continued to March 12, 2002.



# ORDINANCE NO.

ADOPTED BY THE SACRAMENTO CITY COUNCIL

ON DATE OF \_\_\_\_\_

**AN ORDINANCE AMENDING THE SACRAMENTO REGISTER OF THE CITY OF SACRAMENTO TO DESIGNATE AND ADD THERETO A LANDMARK, LOCATED AT 1009 J STREET, KNOWN AT THE BILTMORE HOTEL, PURSUANT TO CHAPTER 15.124 OF TITLE 15 OF THE SACRAMENTO CITY CODE. (PB00-007) (APN: 006-0044-010), DISTRICT 1**

**BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO THAT:**

**SECTION 1.**

Pursuant to Chapter 15.124 of Title 15 of the Sacramento City Code, the Sacramento Register is amended by adding thereto a Landmark, the subject property being known as the Biltmore Hotel and being located at 1009 J Street (APN: 006-0044-010).

**SECTION 2.**

The City Council finds that the building located at 1009 J Street (the Biltmore Hotel) satisfies the requirements of Chapter 15.124. of Title 15 of the Sacramento City Code and is classified as a "Landmark" thereunder, and further, that the building satisfies Section 15.124.170, "Criteria and Requirements for Placement on, and Deletion from, the Sacramento Register" as adopted by the City Council on June 26, 2001 under Ordinance No. 2001-027. The Council bases the foregoing findings on the materials presented as part of the administrative record, including the Staff Report and the nomination materials attached thereto, as well as the testimony presented.
