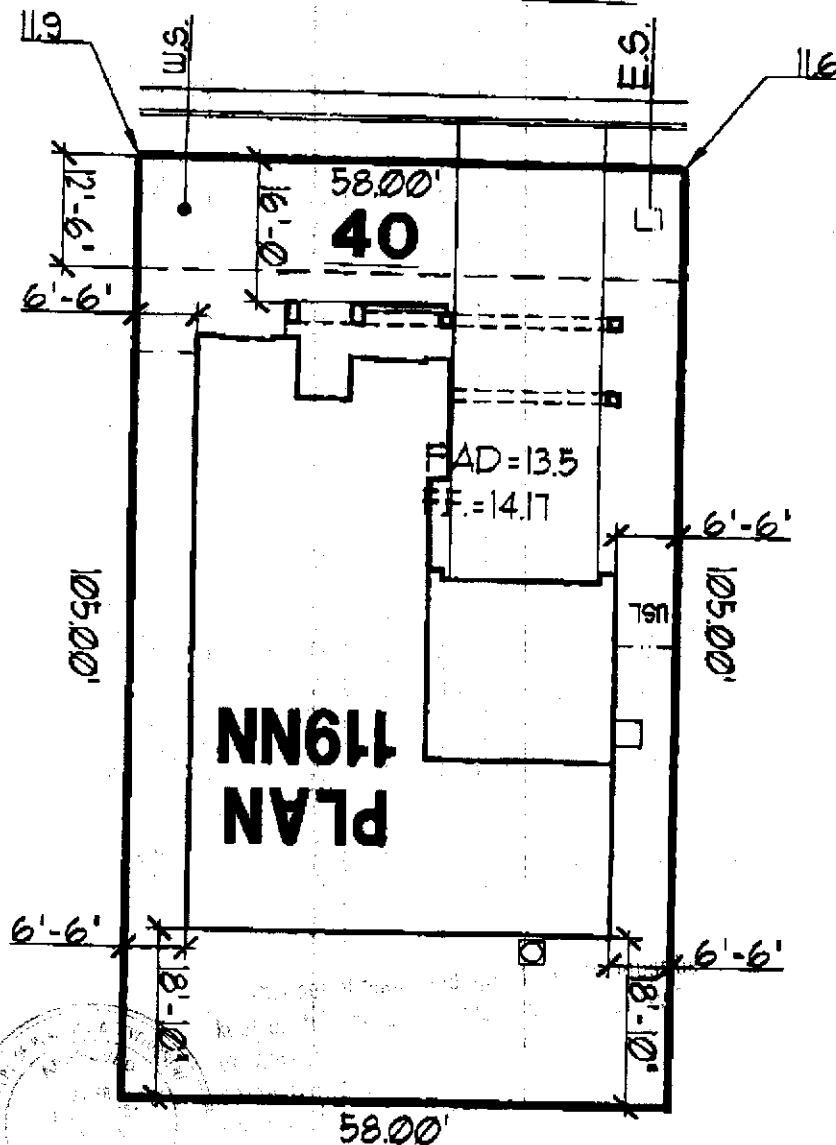


PROPOSED SITE PLAN
