SUBJECT: Metropolitan Arts Division - Appropriation
Increase for California Arts Council Grant

SUMMARY

This report recommends a FY 1981-82 increase of \$14,000 and authorizing the City Manager to execute the contract relating to the award of a California Arts Council Grant.

BACKGROUND INFORMATION

On April 14, 1981, the City Council adopted Resolution Number 81-275 authorizing the City Manager, on behalf of the Sacramento Arts Commission, to submit a grant application to the California Arts Council for the Local Organizational Development Program (Artreach Program Grant).

On October 2, 1981, the Sacramento Metropolitan Arts Commission received notification of a \$25,000 grant award to conduct a community artists' program for twelve calendar months beginning December 1, 1981. \$14,000 will be expended in FY 1981-82 and \$11,000 will be submitted in FY 1982-83.

FINANCIAL DATA

There are no indirect costs associated with this grant. Expenditures will be reimbursed from revenues associated with the grant. A 50% match is required and will be provided through corporate support. There are no additional City or County funds necessary.

RECOMMENDATION

It is recommended that City Council adopt the following resolutions:
