

APROVAL OF CHANGE ORDER NO. 2 FOR THE STOCKTON BOULEVARD AND BROADWAY INTERSECTION IMPROVEMENT PROJECT (PN:TN11)

#### LOCATION AND COUNCIL DISTRICT:

Intersection of Stockton Boulevard and Broadway and 44th Street between 4th Avenue and Broadway. Council District 5.

#### **RECOMMENDATION:**

This report recommends that the City Council adopt the resolution:

- Approving Change Order No. 2 in the amount of \$76,075.61 with Biondi Paving Inc.
- Ratifying the City Manager's execution of a previous Change Order.
- Appropriate \$100,000 from the Measure A Contingency Reserve Fund (201) to the project.

#### **SUMMARY:**

Change Order No. 2 will compensate the contractor for additional costs incurred due to unforeseen conditions. The project is helping to support construction of the new supermarket at the corner of Stockton Boulevard and Broadway.

#### **COMMITTEE/COMMISSION ACTION**

None.

#### **BACKGROUND INFORMATION:**

Change Order #2 for \$76,075.61 will reimburse the contractor for the following:

- Due to a conflict with SMUD poles in the work area, the contractor was required to change his operation for constructing the roadway improvement.
- The heavy rains and existing poor soil conditions required removal of unsuitable soil and replacing it with aggregate base material.

A previous contract Change Order for \$71,114.03 has been executed to reimburse the contractor for the following:

- Placing additional 8" sewer service for a new proposed supermarket.
- Extending a 27" Combined System on Stockton Boulevard at the request of the Utilities Department.

#### FINANCIAL CONSIDERATIONS:

The current project budget is \$768,964.85.

The fund balance for this project as of February 3, 1999 is (-\$13,745).

It is recommended that \$100,000 in Measure A Contingency Reserve funds be appropriated to this project to cover the cost of this Change Order. Staff is working with SHRA and the Department of Utilities to increase their project contribution by \$96,000.00 and \$81,200.00 respectively. Upon receipt of additional funding from SHRA and the Department of Utilities, the Measure A Fund will be reimbursed to the Contingency Reserve.

#### **ENVIRONMENTAL CONSIDERATIONS:**

The Negative Declaration was ratified by the Council on December 18, 1997.
