**Description/Analysis:**

**Issue:** The City's Measure A funding is fully programmed in the City's five-year Capital Improvement Program. Balances accrue interest and the action requested in this report accepts the FY2009/2010 Measure A Construction (Fund 2001) interest allocation in the amount of \$622,028 for future programming.

**Policy Considerations:** Receipt of these funds provides funding for transportation improvements which support the City's Strategic Plan goals to improve and expand public safety, achieve sustainability and enhance livability, and expand economic development throughout the City.

**Environmental Considerations:**

**California Environmental Quality Act (CEQA):** Acceptance of the FY2009/2010 Measure A Construction Interest Allocation is not a "project" as defined by the California Environmental Quality Act (CEQA) Guidelines Section 15378, because it does not involve an activity that will cause a direct or indirect change in the environment. Therefore, it does not require further environmental review. Each project and program is subject to individual environmental analysis.


**Sustainability Considerations:** None.


**Other:** None

**Financial Considerations:** The City received a FY 2009/2010 Measure A Construction interest allocation of \$622,028 in the current fiscal year which will be set aside in Contingency at STA for future Measure A Construction (Fund 2001) programming during the FY2011/2012 annual Capital Improvement Program (CIP) budget approval process.



**BACKGROUND**
