ADDENDUM NO. 1 TO CLARIFY AND MODIFY BID SPECIFICATIONS FOR VEHCILE TOWING/HAULING AND STORAGE SERVICES AND EXTENDING DUE DATE TO MARCH 16, 1982 FOR BID NO. 434

1. The specifications for "Vehicle Towing/Hauling and Storage Services" (Bid 434) provides that vehicle towing services shall be provided within "Posted tow-away zones located within the area of the City of Sacramento bounded by the American River on the north, the Sacramento River on the west, Alhambra Boulevard on the east, and Broadway on the South."

There has been some uncertainty as to what this means. At the present time the only posted tow-away zones within the above area are located on the north side of J Street between Fifth and 14th Streets; and on the south side of L Street between Third and 15th Streets. These tow-away zones are in effect only on Friday and Saturday nights between the hours of 9 p.m. and 2 a.m. There is the possibility, although it may be remote, that tow-away zones may be extended to the Old Sacramento historic area during the term of this contract. However, at the present time towing services to be performed under this contract will apply only to the J and L Streets loop on Friday and Saturday nights as specified.

- 2. Because of the clarification and in order to give bidders additional time to submit their bids, the specifications are hereby modified to provide that bids must be received by the City Clerk, Room 203, City Hall, prior to 10:30 a.m. on Tuesday, March 16, 1982. Bids will not be opened on March 2, 1982.
- 3. The City is calling for this bid pursuant to its authority under the City Charter and City Code.
- 4. All other specifications, terms and conditions of this bid remain unchanged.

Bidders must acknowledge receipt and understanding by signing and attaching one (1) copy of Addendum No. 1 to their bid and submitting it to the City Clerk, Room 203, City Hall, Sacramento, California 95814, prior to the due date for receiving bids.
