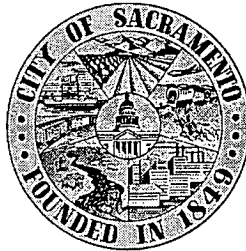

The proposed Community Facilities District (CFD) will include approximately 350 acres in the North Natomas Community Plan area, located in Council District 1 (see Boundary map, Exhibit A).

**RECOMMENDATION:**

    - ✓ Calling for a Special Mailed Ballot Election
2. Direct staff to conduct the election and have the City Clerk present the results during the Staff Reports portion of today's meeting and adopt the following resolution:
  - Resolution Determining the Result of Special Mailed-Ballot Election
3. Pass for Publication of Title the Ordinance to Levy the Special Tax.




NOTICE OF CONTINUANCE OF PUBLIC HEARINGS
