This report recommends that the City Council:

- Award the construction contract to R.C. Collet, Inc. in the amount of \$378,752.10 for the construction of the Lemon Hill Avenue Improvement Project (PN:TN12).

BACKGROUND INFORMATION:

- This project was authorized in a 1996/97 IPA between the City and SHRA.
- This project was advertised and bids were received on May 13, 1998, and are summarized below:

- R.C. Collet, Inc. met the WBE goal but did not meet the MBE goal and performed a good faith effort.
- The construction estimate is \$436,896.
- Approval of plans and specifications and award to R.C. Collet, Inc. is recommended.

FINANCIAL CONSIDERATIONS:

- The project budget for Lemon Hill Avenue Improvement is \$610,700.
- As of May 27, 1998, the Lemon Hill Improvement Project (PN: TN12) had a balance of \$392,119.
- SHRA's additional appropriation to the project is \$44,700. The total funds available for the project are \$436,818, which is sufficient for award of the contract.

ENVIRONMENTAL CONSIDERATIONS:

In accordance with the State Guidelines for implementation of the California Environmental Quality Act (CEQA) of 1970, the Planning Services Division, Environmental Section has reviewed the proposed project. This review has resulted in the determination that the proposed project will not have a significant adverse impact on the environment.

POLICY CONSIDERATIONS:

The action requested herein is consistent with Sacramento City Code, Title 58.

MBE/WBE EFFORTS:

To encourage minority participation, plans and specifications were sent to 8 plan rooms and construction service organizations for publication. Four are directly involved with MBE/WBE construction firms. Staff actively recruited available MBE/WBE firms to participate in the bid process. Project notices were sent to 30 organizations involved in MBE/WBE recruitment. The project was also announced on the Project Information Line and on the City's Internet site at www.sacto.org/bids.
