RESOLUTION ACCEPTING QUITCLAIM DEED

WHEREAS, NETTIE IRENE PHILLIPS

has made, executed and delivered to the City of Sacramento a certain Quitclaim Deed, conveying to the City of Sacramento the following real property in the City of Sacramento, County of Sacramento, State of California, bounded and particularly described as follows:

All that portion of the Southeast one-quarter of Section 16 Township 8 North, Range 5 East M.D.B. & M., described as follows:
Commencing at a 1 inch steel pin monument marking the intersection of the south line of 5th Avenue of the City of Sacramento with the east boundary line of a 10.23 acre tract of land described in a deed dated August 8, 1927, recorded August 31, 1927 in Book 138 of Official Records at page 487, Sacramento County Records, executed by Frank P. Williams and Anna E. Williams, his wife to Sacramento City School District of Sacramento County, from which point of commencement a stone monument marking the one-quarter section corner on the east line of said Section 16 bears south 0° 12' 35" west 18.94 feet and north 89° 55' 20" east 506.41 feet and north 0° 29' 10" east 40.00 feet and north 89° 55' 20" east 679.69 feet and north 89° 44' east 970.00 feet distant; thence, from said point of commencement, south 0° 12' 35" west 449.90 feet, along the east boundary line of said 10.23 acre tract; thence north 89° 47' 35" east 20.00 feet to the southwest corner of the 5.00 acre tract of land described in a deed dated May 27, 1940, recorded July 29, 1940 in Book 830 of Official Records at page 287, Sacramento County Records, executed by Ruth S. Hill to Calurban Investment Company; thence, along the west boundary line of said 5.00 acre tract, north 0° 12' 35" east 449.81 feet to a point on the south line of said 5th Avenue; thence, along the south line of said 5th Avenue, north 89° 57' 40" west 20.00 feet to the point of commencement.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the said Quitclaim Deed be, and the same is, hereby accepted; the City Clerk being directed to attach certified copy hereof to the said Quitclaim Deed, and record same in the office of the Sacramento County Recorder.
