SUBJECT: Repealing Parking Resolution 80-798

SUMMARY

Staff recommendations for removal of parking for implementation of bikeway program and operational changes. The affected residents or businesses have been notified.

BACKGROUND INFORMATION

To implement the Bikeway Master Plan, it is necessary to prohibit parking under certain circumstances. The staff has also found that certain streets require removal of parking for operational needs. The first project of several is 24th Street. The limits are as follows:

- 24th Street between Fruitridge and Kenworthy on the west side,
- 24th Street between 47th and 49th Avenues on the east side,
- 24th Street between 24th Street Bypass and 500 feet south of Gardendale on the east side.

These sections of 24th Street should have parking removed to allow for the installation of Class II bike lanes and restriping to allow for the future installation of a two-way left-turn lane. There will be a very limited number of residents affected. The majority of the area along the west side is Executive Airport and City property or the backs of houses (back lotted) are along 24th Street.

This proposed bicycle project will be done this calendar year as scheduling permits.

To implement operational needs, the following streets have been included in the Parking Prohibition Resolution:

1. Bruceville Road between Valley Hi Drive and the curve east of Alta Valley Drive.
It was necessary to post signs to prohibit parking as large semi tractor trailer

combinations or trailers were parked along the north side of Bruceville Road restricting the visibility on southbound motorists exiting onto Bruceville Road from the commercial properties on the north side. This action was taken on the basis of a request from the Police Department. Parking is available off the street on the north side or along the south curb so no one should be adversely affected.

2. Stockton Boulevard between 13th Avenue and 15th Avenue had parking removed on the east side as the result of a Federal Aid Project. The staff is formally requesting Council approval. Sufficient off-street parking is available.

RECOMMENDATIONS

It is recommended that the City Council repeal Resolution 80-798 and adopt these additions to the resolution prohibiting parking as prepared by the City staff.

RESOLUTION NO. 81-135

A RESOLUTION PROHIBITING PARKING AT ALL TIMES

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Pursuant to Section 25.101 of the Sacramento City Code when signs are erected giving notice thereof no person shall at any time park a vehicle upon any of the following described streets or parts of streets.

- Airport, Sacramento Executive - All streets within;
- Alhambra Boulevard between Folsom Boulevard and Kiesel Street on the east side only;
- Alhambra Boulevard between I Street and Granada Way on the east side only;
- Alhambra Boulevard between J Street and L Street on the west side only;
- Alhambra Boulevard between P Street and R Street on the east side only;
- Alhambra Boulevard between Broadway and X Street on the west side only;
- Alma Way between Irvin Way and Oregon Way on the east side only;
- Arden Way between Blumenfeld/Harvard and Ethan Way;
- Arden Way between Del Paso Boulevard and Oxford Street adjacent to railroad property;
- Bell Avenue between Astoria Street and Winters;
- Belvedere Avenue between Power Inn Road and 82nd Street;
- Broadway between 3rd Street and Front Street, north side only;
- Broadway between 6th Street and a point 320 feet east of 6th Street;
- Broadway between Muir Way and 6th Street, north side only;
- Broadway between Muir Way and 13th Street;
- Broadway between 15th Street and 16th Street;
- Broadway between 28th Street and Alhambra Boulevard;
