SUBJECT: APPROVAL OF PLANS AND SPECIFICATIONS, ACCEPTANCE OF BID,
CONTRACT AWARD, AND FUND TRANSFER OF \$97,200 FOR BROADWAY
RECONSTRUCTION (26th STREET TO 21st STREET) (PN:TR03)

LOCATION AND COUNCIL DISTRICT:

Broadway between 26th Street and 21st Street. Council Districts 4 & 5.

RECOMMENDATION:

This report recommends that the City Council:

- Approve the plans and specifications;
- Adopt the resolution approving a fund appropriation in the amount of \$97,200 to the Broadway Reconstruction (PN:TR03);
- Accept the bid of Environmental Construction in the amount of \$1,145,751; and
- Authorize the City Manager to execute a contract for the Broadway Reconstruction (26th Street to 21st Street) (PN:TR03).

SUMMARY:

This project will reconstruct Broadway between 26th Street and 21st Street. Improvements include reconstruction of existing asphalt concrete, curb, gutter, and installation of a combined storm drainage and sewer system. Sidewalk will not be reconstructed except where handicap ramps are required. The

purpose of the project is to rehabilitate deteriorated streets, improve drainage and improve the overall aesthetics in the area. Street lights will also be added to promote public safety.

BACKGROUND INFORMATION:

- This project was authorized in the 1996/1997 Capital Improvement Program.
- This project was advertised and bids were received on April 15, 1998 and are summarized below:

- Environmental Construction did meet the MBE/WBE goals.
- Approval of the plans and specifications and award to Environmental Construction is recommended.

FINANCIAL CONSIDERATIONS:

The engineer's estimated construction cost was \$1,120,030.00

The estimated total project cost, including all planning, design and construction and construction engineering costs, is \$1,445,405. The current project budget is \$1,305,652. Additional funding appropriations in the amount of \$97,200 will be made to the project as follows:


POLICY CONSIDERATIONS:

MBE/WBE EFFORTS:




