## RESOLUTION APPROVING REPORT AND FIXING TIME AND PLACE OF HEARING THEREON NO. 2892

WHEREAS, the City Council of the City of Sacramento did heretofore, and on the 20th day of December, 19 51, order the preparation by the City Engineer of the City of Sacramento of a Report under the provisions of the "Special Assessment Investigation, Limitation and Majority Protest Act of 1931", and covering certain proposed improvements on

the Alley between X and Y Streets from the Easterly line of Stockton Boulevard to the Westerly line of 45th Street,

in the City of Sacramento; and

WHEREAS, said Report has been duly completed and presented to this City Council;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:

That said Report, having been duly examined and considered by said City Council, the same is hereby approved; and it is hereby ordered that said Report be forthwith filed with the Clerk of this City Council, and that said Clerk endorse thereon the fact and date of its approval.

IT IS FURTHER RESOLUTED that this City Council hereby fixes the 24th day of January, 1952, at the hour of 8:00 o'clock P.M. as the time for hearing upon the said Report; and hereby orders that said hearing shall be held and conducted by the City Council at the City Council Chamber in the City Hall on "I" Street, between 9th and 1Cth Streets, in said City of Sacramento. The Clerk of the City Council is hereby ordered and directed to give notice of said hearing in the time, form and manner provided by law.
