APPROPRIATION OF FUNDS, APPROVING PLANS AND SPECIFICATIONS, AWARDING A CONSTRUCTION CONTRACT, AND EXECUTION OF PROFESSIONAL SERVICES AGREEMENT FOR THE POWER INN ROAD COMPLETE STREET PROJECT (T15145400)

BACKGROUND

- A. The Power Inn Road Complete Street Project (T15145400) will provide a rubberized asphalt overlay, including curb ramp and traffic signal upgrades.
- B. The project was advertised and two bids were received on July 27, 2016. Teichert Construction is the lowest responsive and responsible bidder.
- C. Construction is expected to begin in October 2016 and be completed in December 2016.
- D. A Request for Proposals (RFP) for Construction management services was advertised and Salaber Associates Inc. (SAI) was the selected consultant. SAI has assembled a highly qualified and experienced team to perform construction management services needed for the project.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The Plans and Specifications for the Power Inn Complete Street Project (T15145400) are approved.
- Section 2. The FY15/16 Capital Improvement Program is amended by appropriating \$2,122,340 in federal funds (Federal Capital Grant Fund, Fund 3703) to the Power Inn Road Complete Street Project (T15145400).
- Section 3. The contract for the Power Inn Road Complete Street Project (T15145400) is awarded to Teichert Construction for an amount not to exceed \$1,710,150.
- Section 4. The City Manager or the City Manager's designee is authorized to execute a contract with Teichert Construction in an amount not to exceed \$1,710,150 for the Power Inn Road Complete Street Project (T15145400).

Section 5 The City Manager or the City Manager's designee is authorized to execute a Professional Services Agreement with SAI in the amount not to exceed \$124,115 for construction management services for the Power Inn Road Complete Street Project (T15145400).
