

RESOLUTION NO. 2006-748

Adopted by the Sacramento City Council

October 17, 2006

ACCEPT L.M. COMBS, AS THE LOWEST, RESPONSIBLE BIDDER FOR THE CONSTRUCTION OF THE BING MALONEY GOLF CART STORAGE FACILITY (OB66); TRANSFER \$400,000 FROM THE CITY FACILITY DEFERRED MAINTENANCE PROJECT (CE21) TO THE BING MALONEY GOLF CART FACILITY PROJECT (OB66); AWARD L.M. COMBS THE CONSTRUCTION CONTRACT FOR THE BING MALONEY GOLF CART STORAGE FACILITY (OB66) IN AN AMOUNT NOT TO EXCEED \$701,590; AND AUTHORIZE THE CITY MANAGER TO EXECUTE THE CONSTRUCTION CONTRACT WITH L.M. COMBS CONSTRUCTION FOR THE BING MALONEY GOLF CART STORAGE FACILITY, (OB66) IN AN AMOUNT NOT TO EXCEED \$701,590.

BACKGROUND

- A. City Code Chapter 3.60 identifies the general guidelines for completing contracts for public projects and procedures for bidding and issuing contracts over \$100,000.
- B. The formal bid process for the Bing Maloney Golf Cart Storage Facility project (OB66) has been completed based on the qualifications set forth by the City.
- C. Pursuant to City Code Chapter 3.60.020, it was determined that L.M. Combs, was the lowest responsible bidder with a base bid of \$701,590.
- D. Sufficient funding is available within the City Facility Deferred Maintenance project (CE21) to approve the transfer of \$400,000 to the Bing Maloney Golf Cart Storage Facility project (OB66).
- E. Upon completion of the transfer of funds from the City Facility Deferred Maintenance project (CE21) there will be sufficient funding available within the Bing Maloney Golf Cart Storage Facility project (OB66) to award the construction contract to L.M. Combs in an amount not to exceed \$701,590.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. L.M. Comb is accepted as the lowest, responsible bidder for the base bid for the Bing Maloney Golf Cart Storage Facility (OB66).
- Section 2. Transferring \$400,000 from the City Facility Deferred Maintenance project (CE21) to the Bing Maloney Golf Cart Facility Project (OB66) is approved.

Section 3. The construction contract for the Bing Maloney Golf Cart Storage Facility (OB66) is awarded to L.M. Combs in an amount not to exceed \$701,590.

Section 4. The City Manager is authorized to execute the construction contract with L. M. Combs for Bing Maloney Golf Cart Storage Facility (OB66) in an amount not to exceed \$701,590.


