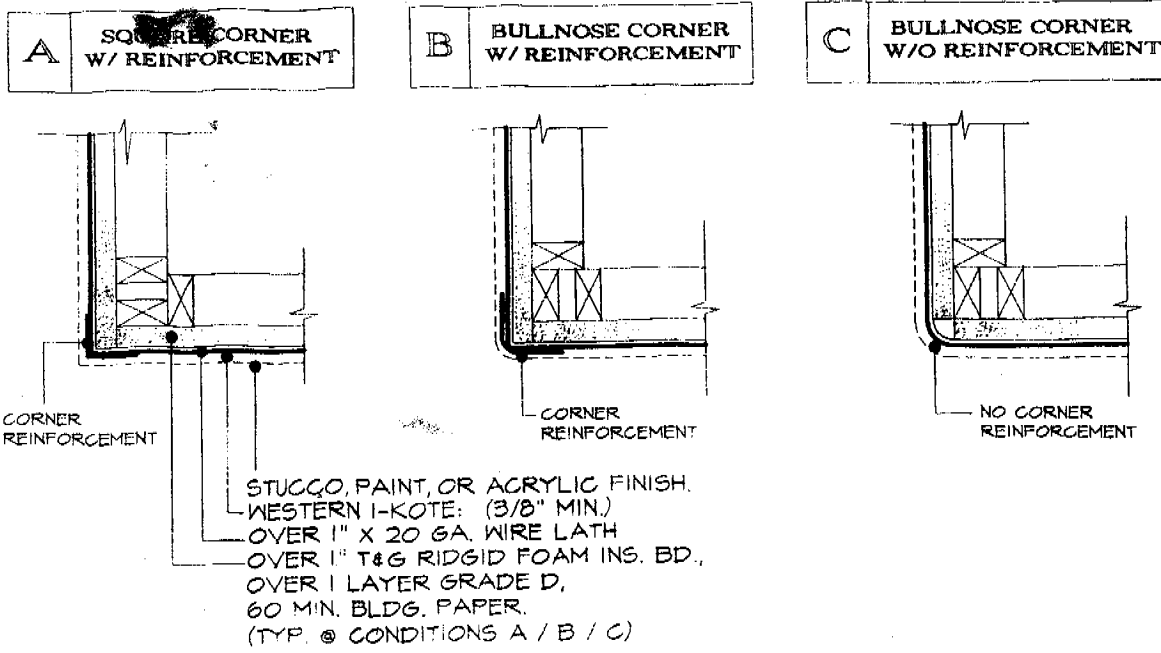


FIGURE 2—TYPICAL INSTALLATION DETAILS—(Continued)
