SUMMARY:

This report provides substantial information to justify the request for removal of a member from the Del Paso Heights RAC as required by Article XV, Section 232, of the Sacramento City Charter.

BACKGROUND:

Pursuant to Section 232 of the Sacramento City Charter, "for good cause a member of a city board or commission who has been appointed for a specified term by the City Council or by the Mayor with the approval of the City Council, may be removed from office during such term by the City Council."

The City Clerk's Office feels that "good cause" is justified due to the following circumstances:

Failure to respond to annual filing notification letters dated 3/28/97, 4/24/97, 5/1/97 and 6/2/97.

Failure to file an annual Statement of Economic Interests form by April 30, as required by City Conflict of Interest Code.

The Office of the City Clerk has provided appropriate noticing in compliance with the provisions of the City Charter.

There is no financial impact associated with this item.


POLICY CONSIDERATIONS
