## Call to Order – 7:05 p.m.

**Roll Call** – A regular meeting of the Parks and Recreation Commission was called to order by Chair Cooke at 7:05 p.m. on Thursday, June 4, 2009 at Belle Coolegge Community Center, located at 5699 South Land Park Drive. All members were present except Commissioners Raya and Lynn.

3. **California Center for Urban Horticulture – Presented by Dave Fujino, Director**

Mr. Fujino presented information on the Center's mission, vision, goals, current projects and upcoming events including conferences, demonstrations and opportunities for increased public access to research gardens at UC Davis. Mr. Fujino reviewed plant species well suited for the Sacramento Valley area, drought tolerant grasses that require less mowing, and efforts to cultivate honeybees. Chair Cooke recommended grasses be tested for use in sports fields and perhaps in partnership with the City of Sacramento.

4. **Life History Writing Program in Older Adults Services – Presented by Westley and Bubbles Jones, Program Volunteers**

Rosanne Bernardy, Recreation Superintendent, introduced the item and the volunteers behind the successful life history writing program held at the Hart Senior Center and the Sierra 2 Center. Mr. and Mrs. Jones gave information on the program they have facilitated for over 1,000 participants to help them share and develop a written life story in a group setting.

Director Combs reviewed new facility openings including an off leash dog park at Sutter's Landing Regional Park and a skatepark at Max Baer Park.


**Questions, Ideas, and Announcements of Commission Members**
