Summary:

Staff recommends Council authorize filing the FY2006/07 Annual Report and set July 18, 2006 as the date for the public hearing. The proposed assessment of \$4,242,636 reflects a 3.0% increase over the FY2005/06 assessment and is the maximum increase allowed. The annual adjustment is based on the most recent Consumer Price Index (CPI). The proposed assessment for a single family residential parcel is \$27.32. The schedule of these annual proceedings is shown on Attachment A. This is the last year of this assessment. The voter approved parcel tax will be effective for FY2007/08.

Committee/Commission Action: This report has been prepared in conjunction with the Sacramento Public Library Authority. No action is required.

Background Information:

On November 5, 1996, City of Sacramento voters approved an assessment district to fund additional library services. The additional services extend open hours, provide more books and materials, and improve technology. The first assessment was placed on the FY 1997/98 County tax roll and is effective for 10 years. The voters also approved an annual increase based on the CPI, San Francisco area, all items, not to exceed 3% in any year. The proposed budget reflects a 3.00% rate adjustment based on the most recent available index which is 3.16%. This CPI adjustment is the only change in the assessment amounts.

On September 9, 1997, City Council approved an agreement between the City and the Sacramento Public Library Authority whereby the City will administer the district. This is necessary to account for the revenue and expenditures of the district and to levy the assessments each year in accordance with City Code Title 3.136.

On November 2, 2004, the registered voters in the City passed Measure X which pertained to a Parcel Tax for Additional Library Services. Fiscal year 2006/2007 will be the final year for the assessment levy for additional library services. In fiscal year 2007/08 the parcel tax will replace the existing assessment for additional library services.

Financial Considerations:

The FY 2006/07 assessments are anticipated to generate approximately \$4,242,636 in revenue and an additional \$9,000 from other sources. The estimated cost for the district totals \$4,308,153 and is detailed in Attachment B. This estimate includes an offset of \$56,517 from the unreserved fund balance projection. All costs incurred including administration of this district are paid for by assessment district revenue. There is no impact to the General Fund.

Environmental Considerations:

Under the California Environmental Quality Act (CEQA) guidelines, the annual proceedings of an assessment district do not constitute a project and is therefore exempt from review.


Policy Considerations:





ADOPTED BY THE SACRAMENTO CITY COUNCIL

DIRECTING FILING OF ANNUAL REPORT FOR THE ADDITIONAL LIBRARY SERVICES ASSESSMENT DISTRICT NO. 96-02 AND SETTING DATE FOR PUBLIC HEARING (PURSUANT TO CITY CODE TITLE 3.136 (Article VI, Section 3.136.180))

BACKGROUND

- A. The Additional Library Services Assessment District No. 96-02 was established by the City Council and approved by the registered voters on November 5, 1996.
- B. The City Council established the District in accordance with the provisions of City Code 3.136.
- C. Pursuant to City Code 3.136.380, an annual report shall be prepared for each fiscal year that assessments are levied.
- D. Pursuant to City Code 3.136.380 a public hearing shall be held to consider the District budget and annual levy.
- E. The City Council is fully advised in this matter.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1: The City Council finds and determines that the background statements A through E are true.
- Section 2: The Development Engineering Manager of the Development Services Department, the person designated by City Council as the Engineer of Work for the District, is hereby directed to file the annual report pursuant to the provisions of the City Code 3.136, Article IV.
- Section 3: Pursuant to City Code 3.136.380, at the hour of 2:00 pm on Tuesday, July 18, 2006, the City Council will conduct a public hearing on the question of the levy of the proposed annual assessment. The hearing will be held at the meeting place of the City Council located in the City Hall, 915 I Street, First Floor, Sacramento, California
- Section 4: This resolution is adopted pursuant to of City Code 3.136, Article IV and Article VI.
