SUBJECT: Additional Title III-C2, Older American Act,
Grant for Sacramento Elderly Nutrition Program (SENP)

SUMMARY

The attached resolution: (1) authorizes the Interim Executive Director to execute an amendment to the FY 1981-82 grant contract with the Area 4 Agency on Aging/Community Services Planning Council for an additional \$9,173 in Title III-C2, Older American Act funds for the Sacramento Elderly Nutrition Program's home-delivered meals program component; and (2) approves a revision of the CY 1982 Agency budget to incorporate the additional grant funds.

BACKGROUND

The California Department of Aging recently extended an additional allocation of one-time-only funds for home-delivered meals programs to the Area 4 Agency on Aging. Of these additional funds, \$9,173 has been awarded on February 1, 1982, by the Area 4 Agency on Aging to the Sacramento Housing and Redevelopment Agency for an expansion of its Elderly Nutrition Program's FY 1981-82 home-delivered meals program operations into the Arden-Arcade area and purchase of related transport equipment. The increased meal service has been accomplished by relocating SENP services from the low-needs Citrus Heights area, in cooperation with other service providers in the Citrus Heights area, to obtain optimum utilization of SENP manpower.

FINANCIAL DATA

The total FY 1981-82 Title III-C2 grant for home-delivered meal service is increased from \$92,560 to \$101,733. The required increased local match is available through in-kind contributions (volunteer services). No additional local funds are required.
