Recommendation: Adopt a **Resolution:** 1) approving Plans and Specifications for the 12th Avenue Overcrossing Railing Repair Project (Project Code 15165); and 2) awarding the contract to Frank Medina for an amount not to exceed \$71,500.

Description/Analysis

Issue: The project consists of removing damaged railing, caused by a vehicular accident, and replacing it in kind with new railing on south side of 12th Avenue between 30th Street and 32nd Street over State Route 99. The project was advertised and bids were received on May 5, 2010. Frank Medina is the lowest responsive and responsible bidder (see Attachment 1). City Council approval is necessary to move forward with awarding a construction contract.

Policy Considerations: The action requested herein is consistent with the Sacramento Strategic Plan goals of improving and expanding public safety.

Environmental Considerations:

California Environmental Quality Act (CEQA): The Community Development Department, Environmental Planning Services Division has reviewed this project and determined that it is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 1, Section 15301(c), Class 2, Section 15302(c), Class 3, Section 15303(d), Class 4, Section 15304(b) and Class 11, Section 15311(a).

Projects exempted under Class 1, Section 15301(c) consist of the operation, repair or minor alteration to existing highways and streets, sidewalks, bicycle and pedestrian trails, and similar facilities. Projects exempted under Class 2, Section 15302(c) consist of the replacement of existing utility systems and/or facilities involving negligible or no expansion of capacity. Projects exempted under Class 3, Section number 15303(d) consist of new construction of small structures including street improvements. Project exempted under Class 4, Section number 15304(b) consist of new gardening or landscaping. Projects exempted under Class 11, Section 15311(a) consist of the construction or replacement of minor structures accessory to existing facilities including but not limited to on-premise signs.




Commission/Committee Action: None.

Rationale for Recommendation: Frank Medina is the lowest responsive and responsible bidder.

Financial Considerations: The 12th Avenue Overcrossing Railing Repair Project (Program Code 15165) has a total cost estimate of \$110,000. The 12th Avenue Overcrossing Railing Repair Project (Program Code 15165) is being delivered by the Department of Transportation, Engineering Services Division. This project has been approved by Human Resources Department, Risk Management Division for full reimbursement.

Emerging Small Business Development (ESBD): The ESBD goal is 20%. To encourage small and emerging business participation, specifications were sent to 18 plan rooms and construction service organizations for publication. All are directly involved with Emerging and Small Business Enterprise (ESBE) construction firms. The project was also announced on the City's Project Internet site at www.cityofsacramento.org/bids. Frank Medina has achieved 100% ESBE participation.



Attachment 1**Background Information:**

In February, the rail barrier on the 12th Avenue overcrossing over SR99 was struck by an automobile resulting in damage to the rail. The project consists of removing damaged railing and replacing it in kind with new railing on south side of 12th Avenue between 30th Street and 32nd Street over State Route 99.

The project was advertised and a total of two bids were received on May 5, 2010. The bids are summarized below:

Contractor	Bid Amount	ESBE Pledged Amount
Frank Medina	\$71,500.00	100%
R.A. Medina	\$125,575.00	100%

The engineer's estimated construction cost was \$77,600. Contract award to Frank Medina is recommended as the lowest responsive and responsible bidder.

Construction is anticipated to be completed by Fall of 2010.

RESOLVES AS FOLLOWS:**

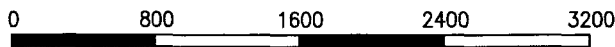
- Section 1. Plans and Specifications for the 12th Avenue Overcrossing Railing Repair Project (Program Code 15165) are approved.
