Dear Sir:

We would like to bid your tree work and we can supply all the necessary equipment and qualified persons to complete the work. However, I find it very difficult to bid according to the form you have provided.

May I be permitted to submit a list of equipment with price rental and operators? This method is being used successfully with the County of Sacramento (Highway Maintenance, County Parks and Recreation). Our contract runs continually and is up-dated annually. Our insurance covers the County for one million dollars PL and PD and can be made for the City of Sacramento also.

Following is the list mentioned above - we ask 72 hours notice for all work to be performed:

Tree Trimmer and his trimming equipment \$20.00 per hour
Ground Person and ropes and ground saw \$20.00 per hour
Laborers for Chipper and clean-up tools \$20.00 per hour
Operators, other saw men and their equipment \$20.00 per hour
Barricades, cones and traffic control equipment is included in our own safety equipment
Hi-Ranger \$200.00 per day - 8 hours (\$25.00 per hour)
Chipper and truck \$100.00 per day (\$12.50 per hour)
"GI" Boom truck \$200.00 per day
Flat bed 2-ton dump truck \$80.00 per day (\$10.00 per hour)
Stump Machine (V4-60-24 inch). Most suited method is to charge \$2.00 per inch of stump diameter, two inches above ground. Clean-up extra.
Can supply small (6 inch) stump machine and Jeep for Parks and other off-road use at the same price.
