SUBJECT: Metropolitan Arts Division - Increase in Appropriations/
California Arts Council Grant

SUMMARY

This report recommends an increase in appropriations for the FY 1981-82 budget of the Metropolitan Arts Division to reflect funds relating to the California Arts Council's State/Local Partnership Program.

BACKGROUND INFORMATION

On June 9, 1981, the City Council adopted Resolution No. 81-417 increasing the FY 1980-81 budget of the Metropolitan Arts Division by \$10,077.50 for arts programming in accordance with the State/Local Partnership Guidelines.

FINANCIAL DATA

No funds related to this grant were expended in FY 1980-81. The entire award will be expended in FY 1981-82. There are no indirect costs associated with this grant and it does not require additional City funds. Grant expenditures will be reimbursed from revenues that have been received from the State of California (California Arts Council) in July 1981 and deposited in the General Fund.

RECOMMENDATION

It is recommended that the City Council adopt the resolution to increase the FY 1981-82 budget of the Metropolitan Arts Division by \$10,077.50 for the purpose of implementing the State/Local Partnership Program Grant.

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

RESOLUTION AMENDING THE CITY BUDGET
FOR FY 1981-82 FOR THE DEPARTMENT OF
COMMUNITY SERVICES (METROPOLITAN ARTS
DIVISION - CALIFORNIA ARTS COUNCIL'S
STATE/LOCAL PARTNERSHIP PROGRAM)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The continuation of a grant from the California Arts Council for the purpose of a local priorities program requires an appropriation increase for the budget of the Department of Community Services.
2. The City budget for FY 1981-82 is hereby amended:
 - a. by adding thereto the sum of \$10,077.50 to budget number 1-01-2281-8284-4258 relating to the expenditure of funds for the purpose stated in paragraph one above.
3. The above appropriation increase is supported by revenue received from the State of California (C.A.C.) and deposited in the General Fund.
