RESOLUTION NO. LAFC 738

RESOLUTION OF THE SACRAMENTO LOCAL AGENCY FORMATION
COMMISSION APPROVING THE EXTENSION OF TIME FOR THE
COMPLETION OF PROCEEDINGS OF THE ZUBIRI REORGANIZATION
(55-78)

WHEREAS, a petition proposing an annexation of territory to the City of Sacramento and the detachment of same territory from the Natomas Fire Protection District known as the ZUBIRI REORGANIZATION was heretofore filed with the Executive Officer of this Commission, and subsequently approved by this Commission on July 5, 1979; and

WHEREAS, the City of Sacramento was designated as the conducting agency to complete proceedings for the ZUBIRI REORGANIZATION; and

WHEREAS, delays in the AB8 property tax base negotiation process have delayed the completion of reorganization proceedings by the City of Sacramento; and

WHEREAS, Section 54799.2 of the California Government Code (Knox Nisbet Act) states:

Failure to complete a proceeding within one year after the Commission approves a proposal therefore shall be deemed an abandonment of such proceeding unless prior to the expiration of said year the Commission shall have authorized an extension of time for such completion...

WHEREAS, the City of Sacramento has no objection to the granting of the extension of time for this reorganization;

NOW, THEREFORE, the SACRAMENTO LOCAL AGENCY FORMATION COMMISSION does hereby find, determine, resolve and order as follows:

1. The SACRAMENTO LOCAL AGENCY FORMATION COMMISSION approves the extension of time for the completion of the ZUBIRI REORGANIZATION (55-78) to July 3, 1981.

2. The conducting agency for the ZUBIRI REORGANIZATION shall remain the CITY OF SACRAMENTO.
