

RESOLUTION No. 294

RESOLUTION DESIGNATING TIME LIMIT REQUIREMENTS FOR THE PARKING OF VEHICLES.

WHEREAS, Under and by virtue of Section 32 of Ordinance No. 304 (4S), as amended by Ordinance No. 775 (4S), the City Manager has found that it is necessary for the convenience of the public to designate the following time limit requirements for the parking of vehicles:

- (a) Parking of vehicles is prohibited on the west side of Front Street (S. P. Sheds), between "I" and "M" Streets;
- (b) Parking of vehicles is prohibited on the south side of California Street, except for unloading;
- (c) Parking of vehicles is prohibited on the east side of Front Street between "I" and "Q" Streets between the hours of 6:00 P.M. and 7:00 A.M.;
- (d) Parking of vehicles is prohibited on the west side of 7th Street between "E" Street and the alley "G"- "H" between the hours of 7:00 A.M. and 6:00 P.M.;
- (e) Parking of vehicles is prohibited for more than ten (10) minutes between the hours of 7:00 A.M. and 6:00 P.M., Sundays and Legal Holidays excepted, on the north side of "I" Street between 8th and 9th Streets, on the east side of 8th Street and on the west side of 9th Street between "I" Street and the driveway back of the Federal Post Office, and on the east side of 6th Street between "H" Street and the alley "H"- "I".
- (f) Parking of vehicles is prohibited for more than one (1) hour between the hours of 8:00 A.M. and 6:00 P.M., Sundays and Legal Holidays excepted, in the following areas:
 - (1) Bounded on the west by the west line of 4th Street; on the north by the north line of "I" Street; on the east by the east line of 16th Street; and on the south by the south line of "L" Street; excepting therefrom such places as are designated as "10 Minute Zones", by green-painted curbs or by appropriate signs, and excepting also therefrom the north side of "J" Street between 15th and 16th Streets;
 - (2) On both sides of 9th Street and both sides of 10th Street between "L" and "N" Streets;
 - (3) On both sides of 12th Street between "N" Street and the alley "N"- "O";
 - (4) On both sides of 11th Street between "P" Street and the alley "O"- "P";
 - (5) On both sides of "P" Street between 10th and 11th Streets
- (g) Parking of vehicles is prohibited for more than two (2) hours between the hours of 7:00 A.M. and 6:00

- (1) Bounded on the west by the west line of 6th Street; on the north by the north line of "H" Street; on the east by the east line of 12th Street; and on the south by the north line of "I" Street;
- (2) Bounded on the west by the west line of 4th Street; on the north by the south line of "L" Street; on the east by the west line of 9th Street; and on the south by the south line of "M" Street;
- (3) Bounded on the west by the east line of 7th Street; on the north by the north line of "N" Street; on the east by the west line of 16th Street; and on the south by the south line of "Q" Street;
- (4) Bounded on the west by the west line of 34th Street; on the north by the north line of Second Avenue; on the east by the east line of 36th Street; and on the south by the south line of Fifth Avenue;
- (5) On "E" Street between 7th and 8th Streets;
- (6) On "J" Street between 38th and 39th Streets;
- (7) On "J" Street between 21st and 22nd Streets;
- (8) On the north side of "M" Street between 28th and 29th Streets;
- (9) On the east side of 28th Street between "L" and "M" Streets;
- (10) On the northeast side of Stockton Boulevard between 32nd and 33rd Streets;
- (11) On the east side of 15th Street between "L" and "M" Streets;
- (12) On "C" Street between 17th and 19th Streets;
- (13) On 18th Street between "B" Street and the alley "C"-"D";
- (14) On "M" Street between 15th and 20th Streets.

Resolution No. 192, adopted May 20 1938, is hereby superseded.


