The City Council and the Board of Supervisors, as the appointing bodies for Regional Transit, wish to advise you of our concerns relative to the selection of a new General Manager and an interim General Manager.

Since the terms of the Board expire this year and it would be unfortunate if a "new" Board were ^{FALED} saddled with unacceptable procedures, we recommend for your consideration the following:

1. The selection of an acting General Manager should be reviewed, prior to the selection, by the City Manager, ~~and~~ the County Executive and the respective elected bodies.
2. The alternate methods of selecting a new General Manager should be reviewed by both the City Manager and the County Executive and a joint report of those individuals, together with John Ketelsen, should be prepared and submitted to both elective bodies ~~to you~~ for review.

In essence, we strongly recommend that you defer any action on ~~the selection of an Acting General Manager or~~ adoption of a method to select the new General Manager until the new Board ~~has~~ has taken office.
