Task A

Install flexible conduit and fittings over exposed existing wiring from exterior to existing panel in laundry room in Morrison Creek Estates and strap conduits per NEC.

Task B

Install surface extension box and reroute existing conduit to side of box per NEC in laundry rooms in Morrison Creek Estates, Terrace and Commons.

Task C

Replace existing non-raintite fittings with raintite fittings on building exteriors and strap existing conduits in Morrison Creek Terrace and Commons.

Task D

Extend conduits to raise fixture location in Morrison Creek Terrace and Commons.

Task E

Install new conduit and conductors from laundry room to new fixture location between bedroom windows in Morrison Creek Terrace and Commons.

Task F

Trench and install new rigid conduit from carport to existing fixture location in Wildwood Area.

Task G

Extend conduit and install new 150 Watt MH Flood at gable top in Wildwood Area.

Task H

Install recycled HPS Floodlite on existing circuit on carport face in Wildwood Area.

Task I

Install 150 Watt MH Flood on existing pole light adjacent swimming pools.

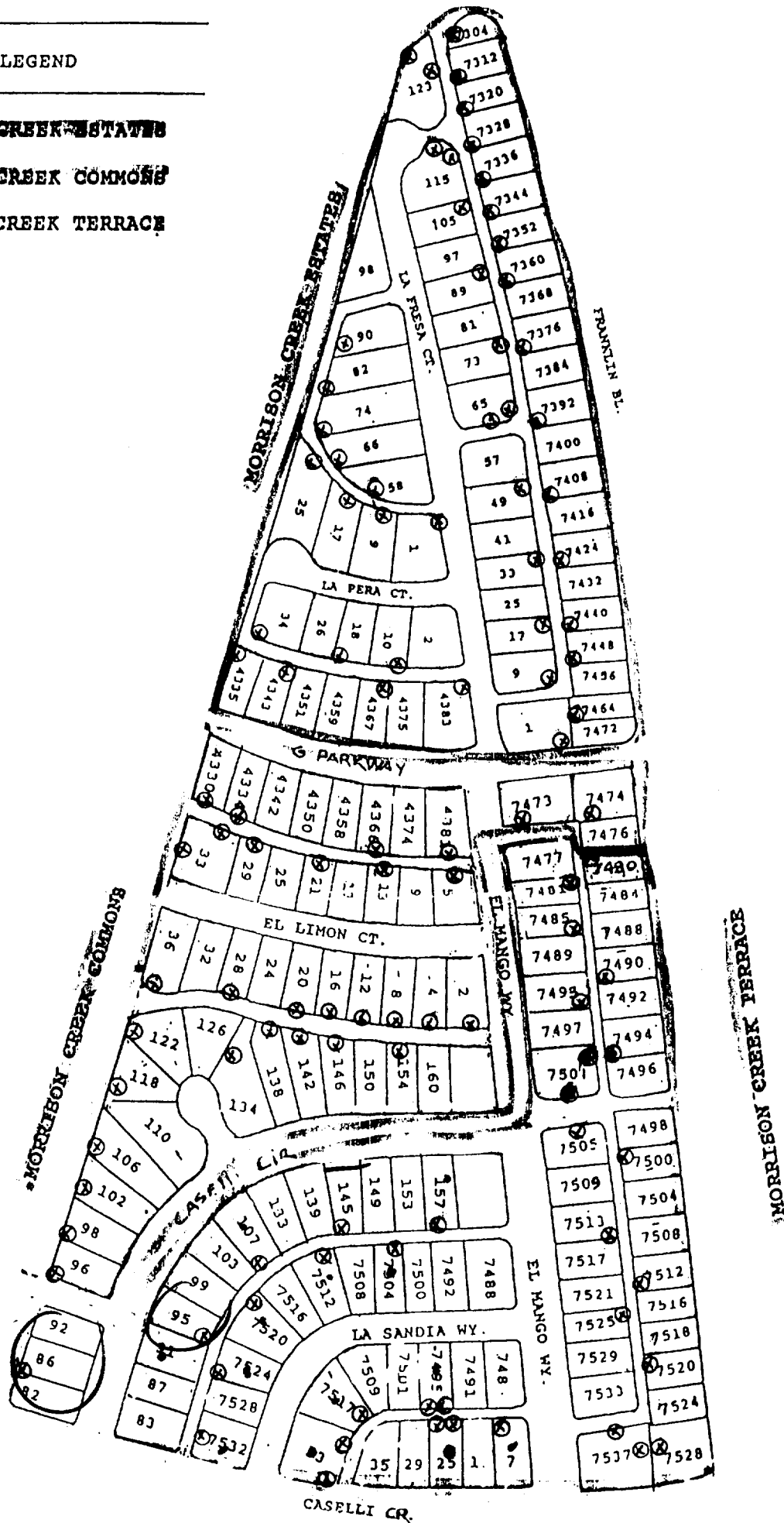
