SUBJECT: RECOMMENDATION TO ANNEX CERTAIN STREETS TO THE
U.C. MEDICAL CENTER RESIDENTIAL PERMIT PARKING
AREA

SUMMARY

This report recommends the annexation of Miller Way, from 39th Street to Y Street, to the U.C. Medical Center Residential Permit Parking Area.

BACKGROUND

The residents of Miller Way, from 39th Street to Y Street, submitted a petition for residential permit parking. Their request is based on the limited off-street parking, and the influx of all-day commuter parking. The area around Miller Way is presently signed for residential permit parking. A petition has been received representing 74% of the residences on the street segment proposed for annexation.

FINANCIAL DATA


The cost to implement this street segment is \$490.00. Funds are available in the Traffic Signs and Markings operation budget and Construction and Building Supplies (101-310-3122-4471).





Pursuant to Section 25.186 of the Sacramento City Code, the following street segment is hereby annexed to the U.C. Medical Center Residential Permit Parking Program.




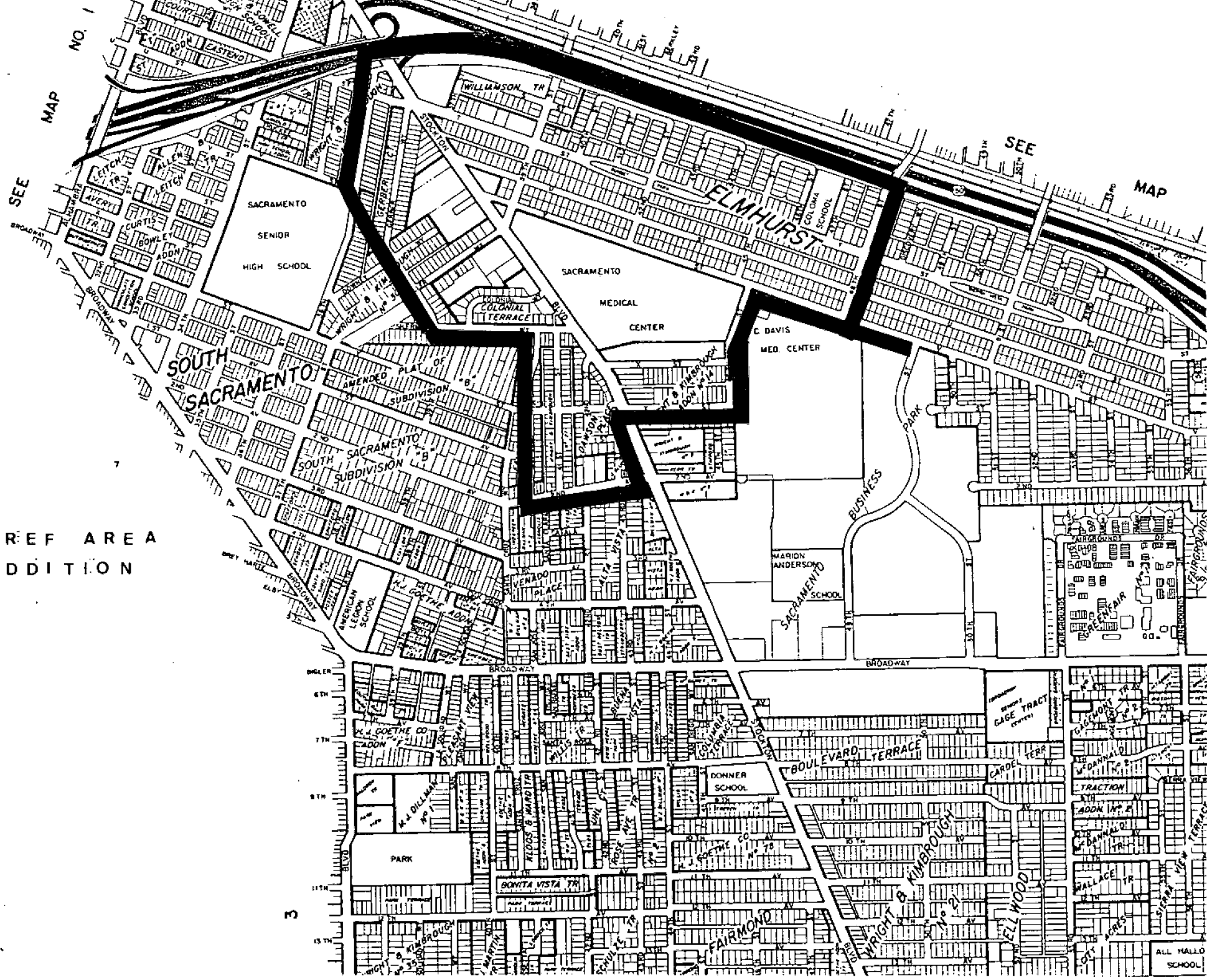
