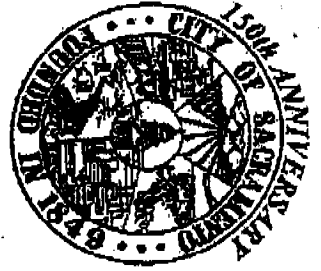

DESCRIPTION OF WORK: REPLACE MAIN SEWER LINE BY HAND DIG
