SUBJECT: Extension of Contract for Deputy Director of Community Development

SUMMARY

Earlier this year the City Council approved the creation of a position of Deputy Director for Community Development, and authorized funding to contract with the County to fill the position until the end of the fiscal year. This report recommends giving the City Manager authorization to extend the agreement for the 1984-85 fiscal year.

BACKGROUND

On March 6, 1984, the City Council approved the reorganization of the Community Development Department and an amendment to the budget to implement the reorganization. At that time, \$15,000 in contractual funding was approved to contract with the County to fund Robert B. Wall as Deputy Director of Community Development for the remainder of the fiscal year. The County desires, and the Board of Supervisors has approved, an agreement that extends through the 1984-85 fiscal year. This agreement has been reviewed by the Community Development Department and the City Attorney, and best meets our operational needs.

FINANCIAL DATA

The total cost of the agreement is \$70,000 for a fifteen-month period. The cost represents only the salary and benefit costs provided to Mr. Wall from the County. The agreement does not include any overhead costs. Funding for this agreement is included in the City Manager's proposed 1984-85 fiscal year budget. There are provisions to allow termination of the agreement if funding is discontinued.
