3. REVIEW OF COMMISSION'S ROLE IN TREE APPEAL HEARING PROCESS

Michael Sparks, Deputy City Attorney, reviewed staff and Commission rules and procedures with the Commission.

STAFF REPORTS:

4. POLICY ON "SMALL PUBLIC PLACES FOR SACRAMENTO"

JP Tindell, Principal Planner, reviewed the content of the staff report and clarified the Department is not recommending a citywide reduction in park acreage service level goals or Quimby requirements per thousand residents. The item will be heard by the City Council on May 30, 2006.

Commissioners discussed and gave input on criteria for small public parks and plazas, and how to best approach on a case-by-case basis; proactively targeting neighborhoods to receive input on potential sites for future pocket parks and plazas; opportunities for smaller recreation amenities such as sports courts and off leash dog parks; the need to provide activities for youth and especially teens; the potential for indoor recreation facilities for high density areas; opportunities for design, programming and/or maintenance partnerships with the private sector, organizations and citizens to create unique and inviting public spaces, and the cost effectiveness of designing areas with more trees and less turf and shrubs.

Motion approved to support the proposed policy direction to focus small public parks in higher density areas of the City and park deficient neighborhoods.


COMMISSIONER'S IDEAS, QUESTIONS AND ANNOUNCEMENTS


The Parks and Recreation Commission meeting adjourned at 7:23 p.m.
