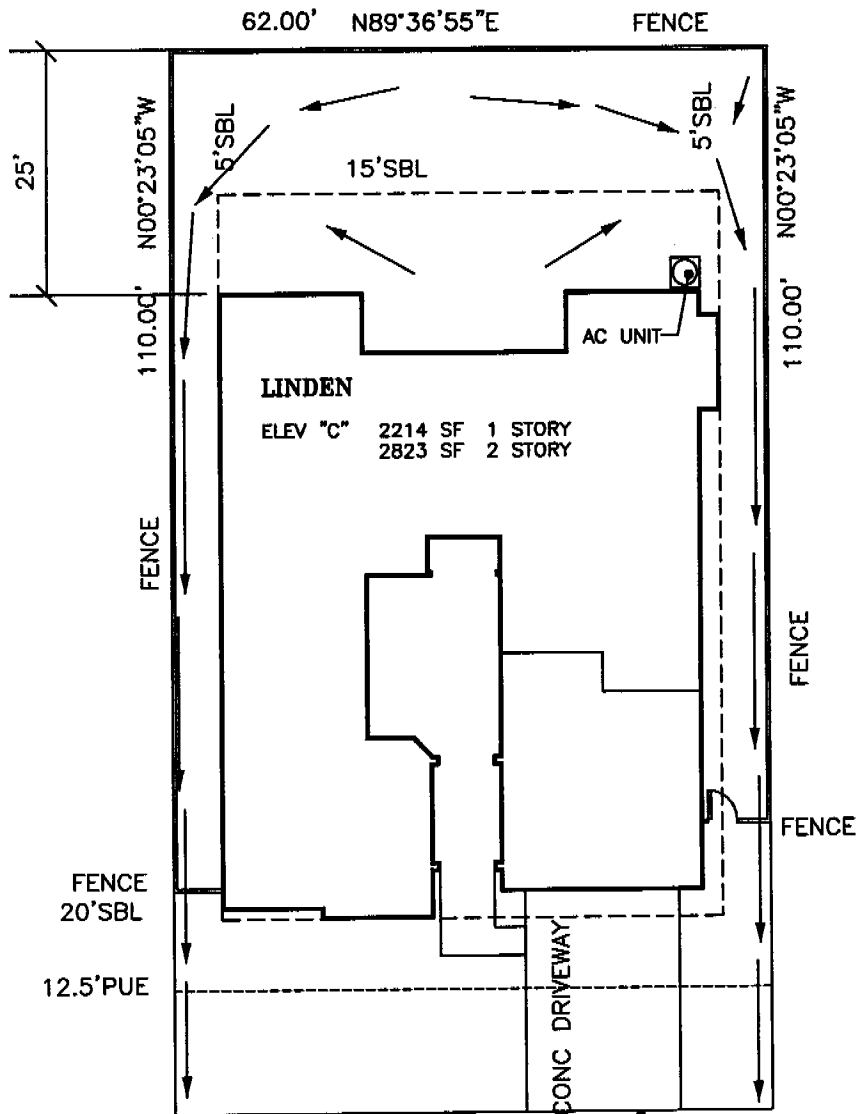

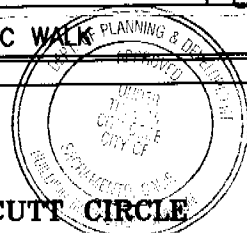

ORCUTT CIRCLE



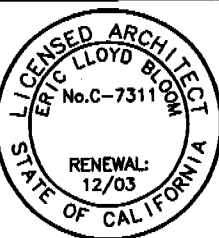
