- A. MEADOWVIEW DEVELOPMENT ADVISORY COMMITTEE to fill three (3) seats. This opening represents all seats with expired terms. Appointees shall be nominated by Council District 8, appointed by the Mayor and approved by the City Council.

OPEN APPLICATION PERIOD 05-24-06; APPLICATIONS DUE 06-23-06.

- B. ANIMAL CARE SERVICES CITIZENS ADVISORY COMMITTEE to fill three (3) positions. This opening represents two (2) seats with term expirations in April, and one (1) seat where appointee resigned prior to the term expiration in 2008. Appointees shall be appointed by the Mayor and approved by the City Council.
