

# RESOLUTION NO. 85-030

APPROVING AND ADOPTING THE REPORT TO THE CITY COUNCIL ON THE PROPOSED AMENDED REDEVELOPMENT PLAN FOR THE DEL PASO HEIGHTS REDEVELOPMENT PROJECT, SUBMITTING SAID REPORT, PROPOSED AMENDED REDEVELOPMENT PLAN AND FINAL EIR RELATING THERETO TO THE CITY COUNCIL, AND CONSENTING TO CALL A JOINT PUBLIC HEARING ON SAID AMENDMENT AND THE FINAL EIR RELATING THERETO

WHEREAS, the Redevelopment Agency of the City of Sacramento (the "Agency") has prepared a proposed Amended Redevelopment Plan (the "Amended Plan") for the Del Paso Heights Redevelopment Project (the "Project"); and

WHEREAS, the Agency has submitted the proposed Amended Plan to the Planning Commission of the City of Sacramento for its report and recommendations, and the Planning Commission, at its meeting on April 3, 1985, reviewed the proposed Amended Plan and found the Amended Plan to be consistent with the proposed amendment to the General Plan which is proposed to be adopted prior to the ordinance approving and adopting the Amended Plan; and

WHEREAS, pursuant to the California Environmental Quality Act, the State CEQA Guidelines and the Agency procedures adopted pursuant thereto, the Agency has prepared and completed a proposed Final Environmental Impact Report ("Final EIR") for the Project; and

WHEREAS, pursuant to Section 33352 of the California Community Redevelopment Law (Health and Safety Code Section 33000 et seq.), the Agency has prepared a Report to the City Council on the proposed Amended Plan; and

WHEREAS, Section 33458 on the Health and Safety Code authorizes a joint public hearing on the proposed Amended Plan with the consent of the Agency and the City Council of the City of Sacramento; now, therefore,

Section 1: The Agency hereby approves and adopts the Report to the City Council on the proposed Amended Plan and hereby submits said Report, together with the proposed Amended Plan and the Final EIR on the proposed Amendment, to the City Council.

Section 2: The Agency hereby consents to a joint public hearing on the proposed Amended Plan and requests the City Council to call a joint public hearing of the Agency and the City Council on Tuesday, May 14, 1985, at 7:30 p.m. in the City Council Chambers to consider and act upon the proposed Amended Plan and all documents and evidence pertaining thereto, together with a joint public hearing on the Final Environmental Impact Report for the Amended Plan.

Section 3: The Secretary of the Agency shall, in cooperation with the Clerk of the City of Sacramento, prepare, publish and mail such notices and documents and do all other acts as may be necessary to carry out the purposes of this resolution.
