

RESOLUTION OF INTENTION #2713

WHEREAS, in the opinion of the City Council of the City of Sacramento, public interest and convenience require that the work and improvement hereinafter described in the City of Sacramento, State of California, should be done:

NOW, THEREFORE, the said City Council of the City of Sacramento does hereby resolve and declare that it is the intention of the said City Council to order the following work and improvement to be done in said City, to-wit: TO CLOSE, VACATE, AND ABANDON THE FOLLOWING:

4th Street from the Southerly line of P Street to the Northerly line of Q Street; and the Alley in the block bounded by P and Q Street from the easterly line of 3rd Street to the westerly line of 4th Street, in the City of Sacramento.,

reserving however, the right of entry to repair maintain and construct sewer, water and gas pipes and aerial or underground power, telephone and other communication facilities, now in place in said Street^{and Alley} or which from time to time may be placed therein. All proceedings in connection with the aforesaid closing are to be taken subject to such reservations and exceptions.

And said City Council does hereby determine and declare that said proposed work and improvement is of more than local or ordinary benefit, and will affect and benefit the lands and district hereinafter described, and which said District is hereby declared to be the district affected and benefited by said work and improvement and that therefore the entire damages, costs, and expenses of said work and improvement shall be and are hereby made chargeable against, and shall be assessed upon said lands and district, which district is within the City of Sacramento, County of Sacramento, State of California, and the exterior boundaries of the lands affected and benefited by said work and improvement are particularly described as follows, to-wit:

On the North by P Street,
On the South by Q Street,
On the East by 5th Street,
On the West by 3rd Street


And the City Council does hereby elect to proceed to do said work

under the provisions of Division 9 Part 3 Streets and Highways Code, The Street Vacation Act of 1941, being an Act of Legislature of the State of California, Approved May 13th, 1941: and hereby fixes the 23rd day of July, 1948 at 8:00 o'clock P.M., in the City Council Chamber in the Sacramento City Hall on I Street, between 9th and 10th Streets of said City, as the time and place when and where any and all persons interested in said work and improvement may appear before the said City Council of said City and be heard by said City Council upon such appeal, and show cause, if any they have, why the said Improvement should not be made.

The Sacramento Union is hereby designated as the daily newspaper published and circulated in said City, in which this Resolution shall be published; and the Superintendent of Streets is hereby directed to post notice of the passage of this Resolution in the manner prescribed by Law.
