9. SUPPORT CELL TOWERS AT PANNELL/MEADOWVIEW & REICHMUTH PARKS

CAC members expressed concerns about the placement of a cell tower at Reichmuth Park and discussed what other possible alternatives or sites were considered before the request to place a cell tower in the park. Chairperson John Andrew expressed concerns with Reichmuth Park having quite a few encroachments in place already; a Fire Station and large utility pump station, and would like to see mitigation impacts to the park be addressed.

Jed Peters, Complete Wireless Consultant, explained that other areas were explored but it was concluded that because of Reichmuth Park's central location, the cell tower would be the best and only functional placement in the area.

Members also had concerns about use of fee revenues generated from the cell towers located in City parks, and were they going directly back to the parks? Staff responded the revenue is held in cell tower accounts and is allocated by the Councilmember whose district the park is in. Parks and Recreation staff make recommendations on uses, and the revenues are generally spent in the park.

CAC members requested a reportback from staff on a rehabilitation plan for Reichmuth Park. Members requested that environmental considerations and impacts be addressed for cell tower placements in parks. Bob Overstreet, Director, Department of Parks and Recreation, stated that staff will address the process for environmental considerations related to cell tower placements in future reports.

The CAC determined to separate the two proposed locations under discussion and make a motion on each one.

STAFF REPORTS:

11. WORKSHOP ON 2004 PARKS & RECREATION MASTER PLAN UPDATE DRAFT

Ms. J.P. Tindell, Department of Parks and Recreation Master Plan Consultant, provided updates on the schedule of public meetings for Master Plan final approvals, the favorable outcome of the Planning Commission review and comment session meeting held September 23, 2004, the revised Master Plan's Implementation Chapter, the amended special community sports field/user study, and updates on other aspects of the project. Staff is in the process of finalizing the Master Plan, which will be presented to the CAC in November for recommendation to City Council.

Representatives from Pacific Municipal Consultants (PMC) presented an overview of funding options and what is needed to implement the Master Plan for inclusion in the Master Plan's Implementation Chapter. The Master Plan will include information about a range of funding options that can be considered to provide the additional resources need to implement the Plan.

Members suggested creation of endowments, development agreements, annuities and community school partnerships to assist with financing efforts. Members also had gender split/participation concerns reflected in the "Special Community Sports Field/User Study" material and would like to see projected growth data as well as demographic information added to this study. Members requested a map that would identify lighted and non-lighted sport fields. Ms. Tindell requested that any additional comments on the "Special Community Sports Field/User Study" be sent to her by Wednesday, October 6, 2004.

John Andrew suggested setting priorities by adding timeframes for Implementation Plan items and that deficiencies be addressed.

CAC MEMBERS IDEAS, QUESTIONS AND ANNOUNCEMENTS

George Raya commented on a public meeting conducted by the CAC Tree Ad-Hoc Advisory Committee held at Blue Diamond Growers on September 29, 2004. Per Mr. Raya, the forum was successful and well attended by stakeholders and received media coverage. He complimented Department staff for their good staff work and information.

John Andrew reminded members the filing period deadline for the new Parks and Recreation Commission is Friday, October 15, 2004. Mr. Andrew also reminded members that the CAC Fall park tour which is scheduled for Saturday, October 30, 2004.
