Subject: ORDINANCE NUMBERING

SUMMARY

The City Clerk's office is currently revising and updating the Council Minute Index from a manual system to an automated system. As part of the revision, it has been determined that the method of numbering ordinances be changed.

BACKGROUND

The ordinances were numbered consecutively and were designated as First Series, Second Series, etc. The designation of ordinance series was used to reflect changes in the type of City government.

It is requested that the manner of numbering be changed to show year of adoption, numbered consecutively and delete any reference to series.

The new numbering system will conform to the current method of numbering resolutions. It will also allow a standardization of data input into the automated indexing system.

RECOMMENDATION

1. It is recommended that the attached resolution be continued to January 6, 1981, pursuant to Council rule of Procedure 13A relating to amendments.





RESOLUTION AMENDING RESOLUTION NO. 76-136
AS AMENDED RELATING TO CITY COUNCIL RULES
OF PROCEDURE (ORDINANCE NUMBERING)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

That Resolution 76-136, as amended, is hereby further amended by repealing and re-enacting City Council Rule of Procedure 7-h to read as follows:

"7-h Ordinance Numbering

Commencing January 1, 1981, ordinances adopted by the City Council shall be numbered so as to indicate the year and the sequence of their adoption. Ordinances shall be numbered consecutively for each year, beginning with number one, according to the order of their adoption. The first ordinance adopted in each calendar shall be designated number one. This number shall be preceded by the last two digits of the calendar year in which the ordinance is adopted. Therefore, the number of the first ordinance adopted in 1981 will be "Ordinance No. 81-1".

SECTION 2.

All other provisions of the City Council Rules of Procedure previously adopted shall remain in full force and effect.
