#### STAFF RECOMMENDATION

It is recommended that the City Council adopt specifications and accept the lowest responsible bids for the contracts resulting from Bid No. 1681 for Plumbing Supplies for Water Distribution. Award is being recommended to the following contractors: Camellia Valley Supply; Westburne Supply, Inc.; and Familian Pipe & Supply, in the total amount of \$174,722.39.

#### **SUMMARY**

Attached is a tabulation of sealed proposals for furnishing supplies in accordance with the specifications used in the bidding process, and recommendation of award for Bid No. 1681 for Plumbing Supplies for Water Distribution, a Division of the Utilities Department.

## **BACKGROUND**

This contract is for various inventoried underground plumbing supplies to be used by the Water Distribution Division of the Utilities Department.

### FINANCIAL CONSIDERATIONS

These purchases are initially charged to the Water Distribution Division's general inventory account whereby the items are debited to the Division's operating budget for plumbing and supplies as the items are disbursed.

## **ENVIRONMENTAL CONSIDERATIONS**

Ongoing administrative and maintenance activities, such as purchases of supplies, equipment or material which are not made for purposes of a public works construction project, do not constitute a "project" and are exempt from the California Environmental Quality Act (CEQA). CEQA Guidelines, Sections 15061(b)(1), 15378(b)(3).

### **POLICY CONSIDERATIONS**

This recommendation is consistent with the requirements for competitive bidding as detailed in Title 57 of the Sacramento City Code.

### MBE/WBE EFFORTS

Requests for bid (RFB) were sent to fifteen vendors, seven of which are M/WBE firms. Of the five responses received, one was from a City-certified Minority Owned Business Enterprise, Shawnee Electric Company. However, since theirs was not the lowest responsible bid, award is not being recommended to this vendor.
